10 Be it ordained by the People of the City and County of San Francisco:

11 Section Findings. The Board of Supervisors of the City and County of San Francisco
12 hereby finds and determines that:

13 (a) Pursuant to San Francisco Charter Section 4.105 and Planning Code Section
14 340, any amendments to the General Plan shall first be considered by the Planning
15 Commission and thereafter recommended for approval or rejection by the Board of
16 Supervisors. On June 14, 2012, the Planning Commission conducted a duly noticed public
17 hearing on the proposed 2012 Community Safety Element update pursuant to Planning Code
18 Section 340 and, by Resolution No. 18646, adopted the 2012 Community Safety Element
19 update, and recommended it for approval to the Board of Supervisors. A copy of Planning
20 Commission Resolution No. 18646 is on file with the Clerk of the Board of Supervisors in File
21 No. 120463.

22 (b) The Board of Supervisors finds that the proposed 2012 Community Safety
23 Element update is in conformity with the priority policies of Planning Code Section 101.1 and
24 on balance is consistent with the General Plan as it is proposed for amendment herein, and

1 hereby adopts the findings set forth in Planning Commission Resolution No. 18646 and
2 incorporates such findings herein by reference.

3 (c) Pursuant to Planning Code Section 340, the Board finds that the proposed 2012
4 Community Safety Element update will serve the public necessity, convenience and welfare
5 for the reasons set forth in Planning Commission Resolution No. 18646, which reasons are
6 incorporated herein by reference as though fully set forth.

7 (d) California Environmental Quality Act. On May 23, 2012, the Environmental
8 Planning Division of the Planning Department published a Preliminary Negative Declaration,
9 which reviewed and analyzed the proposed 2012 Community Safety Element update and
10 found that the proposed update would not have a significant effect on the environment.
11 Because the proposed update was found to have either a less-than-significant impact or no
12 impact under all impact areas, no mitigation measures were required. The Preliminary
13 Negative Declaration was provided for public review from May 23, 2012 until June 12, 2012.
14 On June 12, 2012, it was finalized as the Final Negative Declaration (FND). In accordance
15 with the actions contemplated herein, this Board has reviewed the FND and concurs with its
16 conclusions and finds that the actions contemplated herein are within the scope of the Project
17 described and analyzed in the FND. The Board hereby adopts and incorporates by reference
18 as though fully set forth herein the FND, which is on file with the Clerk of the Board of
19 Supervisors in File No. 120469.

21 Section 2. The Board of Supervisors hereby amends the San Francisco General Plan
22 by adopting the 2012 Community Safety Element, as the Community Safety Element of the
23 San Francisco General Plan, as recommended to the Board of Supervisors by the Planning
24 Commission on June 14, 2012, and referred to above.


1 Section 3. The Board of Supervisors hereby approves the following amendment to the
2 General Plan Land Use Index:

3 The Land Use Index shall be updated as necessary to reflect the amendments set forth
4 in Section 2, above.

5
6 Section 4. Effective Date. This ordinance shall become effective 30 days from the
7 date of passage.

8
9 Section 5. In enacting this Ordinance, the Board intends to amend only those words,
10 phrases, paragraphs, subsections, sections, articles, numbers, punctuation, charts, diagrams,
11 or any other constituent part of the General Plan that are explicitly shown in this legislation as
12 additions, deletions, Board amendment additions, and Board amendment deletions in
13 accordance with the "Note" that appears under the official title of the legislation.
