WHEREAS, Pursuant to Charter Sections 2.103 and 13.101, the Board of Supervisors (Board) shall meet for an Inaugural meeting at 12:00 noon on the eighth day of January, following the date of an election; and

WHEREAS, The Board's Rules of Order, Section 6.2, states the Board shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at 2:00 pm, unless it is a holiday, in which case the meeting shall be canceled; and

WHEREAS, The Rules of Order Section 6.2 also states the Board shall not meet during the week after Thanksgiving, nor between December 24 and December 31; and

WHEREAS, Independence Day, July 4, 2013, is not subject to Board Rule 6.2; and should the Board wish to observe the July 4<sup>th</sup> holiday shall cancel the regular Board meeting on Tuesday, July 2, 2013; and

WHEREAS, Similar to other sitting legislative bodies in the United States, the Board has established recess periods during the summer and winter which Members of the Board may plan to be away, without missing any Board or Committee meetings or other important public business, and without causing difficulties in achieving a quorum; and
