A copy of said legislation is on file with the Clerk of 21 the Board of Supervisors in File No. 120902 and is incorporated herein by reference; and 22 WHEREAS, On or about September 19, 2012, the Clerk of the Board of Supervisors 23 referred the proposed ordinance to the Planning Commission, which currently is reviewing the proposed ordinance; and 24

10	Commission additional time to review the proposed Ordinance and render its decision; now,

12	RESOLVED, That by this Resolution, the Board hereby extends the prescribed time
13	within which the Planning Commission may render its decision on the proposed Ordinance for
14	approximately 90 additional days, until March 1, 2013.
