[Dissolving Area Plan Infrastructure Finance Committee]

WHEREAS, Resolution No. 432-10 established an Area Plan Infrastructure Finance Committee to supervise a consultant study to develop policy criteria and recommendations on the use of Infrastructure Finance Districts (IFDs) in newly adopted Area Plans, including within the Eastern Neighborhoods Area Plan, determine the appropriate steps to form IFDs, and to supervise the formation of a pilot IFD in Rincon Hill; and

WHEREAS, Rule 2.21 of the Board of Supervisors' Rules of Order requires the Clerk of the Board to determine and identify each year every subordinate body that has not met at least once every four months, and to ask the City Attorney to prepare legislation repealing the ordinance or resolution that created the body; and
