3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**  
4 **public premises license to Lynne Carmichael for Eno St. Francis, LLC, dba Eno,**  
5 **located at 310-320 Geary Street (District 3), will serve the public convenience and**  
6 **necessity of the City and County of San Francisco, in accordance with Business**  
7 **and Professions Code, Section 23958.4, with conditions.**

9 WHEREAS, Lynn Carmichael is seeking the issuance of a Type 42 on-sale beer  
10 and wine license for Eno, located at 310-320 Geary Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned and recommends approval; and,

13 WHEREAS, The Police Department has filed zero (0) protests with the  
14 Department of Alcoholic Beverage Control under California Business and Professions  
15 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
16 Control issue the liquor license with conditions; and

17 WHEREAS, The conditions recommended by the Police Department are the  
18 following: 1) Sales, service, and consumption of alcoholic beverages shall be permitted  
19 only between the hours of 10:00 a.m. and 12:00 a.m. midnight daily; 2) No noise shall  
20 be audible beyond the area under control of the licensee(s) as defined on the ABC-257;  
21 and 3) The petitioner shall utilize electronic surveillance and recording equipment that is  
22 able to view the outside of the premises, including all entrances and exits, and that is  
23 actively monitored and recorded. This electronic surveillance shall be utilized during  
24 operating hours. Said electronic recording shall be kept at least 30 days and shall be

1 made available to the Department and Police Department upon demand; now,  
2 therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines for the foregoing reasons that the issuance of a Type 42 on-sale  
6 beer and wine license to Lynne Carmichael for Eno St. Francis, LLC, dba Eno, located  
7 at 310-320 Geary Street, will serve the public convenience or necessity of the City and  
8 County of San Francisco; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
10 San Francisco hereby endorses and adopts the recommendations of the Police  
11 Department listed above, and recommends that the Department of Alcoholic Beverage  
12 Control issue the license with those conditions.
