6 WHEREAS, The Japanese Bilingual Bicultural Program (JBBP) was founded in 1973
7 and serves students in kindergarten through fifth grade at Rosa Parks Elementary School,
8 located at 1501 O'Farrell Street in the historic home of Japantown in San Francisco; and

9 WHEREAS, The students in the program are taught by native Japanese speaking
10 "Senseis" and state credentialed teachers who assemble to teach authentic Japanese
11 language and culture through daily and special activities, conversation, reading, and writing in
12 Japanese, in addition to and integrated with the California core curriculum; and

13 WHEREAS, The JBBP will be presenting a 40th Year Anniversary Celebration, entitled
14 "Omedetou – Honoring our Founders," on Saturday, March 9, 2013, starting at 4:30 pm at the
15 St. Mary's Cathedral Event Center; and

16 WHEREAS, At the Celebration, ten Founders and two Honorary Founders of the
17 Program will be recognized; and

18 WHEREAS, The Spirit of the Founders Awards will be presented to four individuals
19 who have made critical contributions to the survival and success of the program during recent
20 years; now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
22 commends and congratulates the founders, staff, students, parents, and alumni of the JBBP
23 on their 40th Year Anniversary and wishes them well in the future; and, be it

24 FURTHER RESOLVED, That the Board of Supervisors declares March 9, 2013, Rosa
25 Parks JBBP Day in the City and County of San Francisco.


