3	Ordinance amending the Fire Code, Chapter 5, Section 503.4, to clarify what does not
4	constitute an obstruction of a Fire Apparatus Access Roads.
5

9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. Findings.
11	The Board of Supervisors finds pedestrian safety and reduction of pedestrian fatalities
12	at intersections and other legal crosswalks are important City policy objectives.
13	In December 2010, the Board of Supervisors adopted the Better Streets Plan. A core
14	principle underlying the Better Streets Plan is that streets that the City must design, build, and
15	operate should strike a balance among all users of streets regardless of physical abilities or
16	mode of travel, with the objective of making streets better and safer resources for all the
17	people who live or work in San Francisco. The construction, design, and operation of streets
18	must serve the paramount public interest in maintaining the livability of the City; taking into
19	account, and striking a balance among, the needs of pedestrians, bicyclists, motorcyclists,
20	and those who travel by private automobile, as well as those who travel by bus, streetcar, or
21	other mass transit; considering also such factors as street trees, storm water management,
22	utilities, as well as vehicular circulation and parking. But in this mix of factors, pedestrian
23	safety must be given a high priority.
24	The Board of Supervisors finds that installation of pedestrian "bulb outs" at
25	intersections and crosswalks, extended from sidewalks or medians, will enhance pedestrian

1 safety. A pedestrian "bulb out" exists when the sidewalk or median at the intersection or at

- 2 another legal crosswalk is extended into the street, thereby reducing the distance pedestrians
- 3 must travel to cross the street.
- The Board of Supervisors further finds that bulb outs will also force traffic to slow down
 and improve the capacity of vehicle drivers to see pedestrians.
- 6 The Board of Supervisors further finds that increasing the number of bulb outs in the7 City is consistent with the Better Streets Plan.
- 8 In adopting this ordinance, the Board of Supervisors does not intend to amend the

9 California Fire Code, reduce the powers of the fire code official, or compromise fire safety.

- 10 This legislation intends only to interpret what constitutes an obstruction of a fire apparatus
- 11 access road under California Fire Code Section 503.4.
- 12 Section 2. The San Francisco Fire Code is hereby amended by amending Section
- 13 503.4, to read as follows:

14 SECTION 503 – FIRE APPARATUS ACCESS ROADS

15 503.4 [For SF] Obstruction of fire apparatus access roads. Fire apparatus access roads

16 shall not be obstructed in any manner, including the parking of vehicles. *Subject to Health and*

17 Safety Code Sections 13104, 13108, 13114, 18941.5, and California Fire Code Sections 104.1, 1.11.2,

18 *and 503, the portion of the sidewalk or median, immediately adjoining and extending into a roadway,*

19 *that has no utility pole, street light, street furniture, fire hydrant, trees, shrubbery, or other structure or*

- 20 *natural growth attached thereto and that has a height that does not exceed six inches above the*
- 21 *roadway shall not constitute an obstruction of a fire apparatus access road.* The minimum widths
- 22 and clearances established in Section 503.2.1 shall be maintained at all times.
- 23 Section 3. Effective Date. This ordinance shall become effective 30 days from the

24 date of passage.

1	Section 4. In enacting this ordinance, the Board intends to amend only those words,
2	phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts,
3	diagrams, or any other constituent parts of the Fire Code that are explicitly shown in this
4	ordinance as additions, deletions, Board amendment additions, and Board amendment
5	deletions in accordance with the "Note" that appears under the official title of the ordinance.
