WHEREAS, Assembly Bill 1199 (AB1199), sponsored by Assembly member Paul Fong, would create a smoothing formula for enrollment-related funding losses for any community college that is under severe sanction from accreditation agencies and is also suffering an enrollment decline; now, therefore, be it
