8	WHEREAS, The Electorate of the City and County of San Francisco passed			
9	Proposition J in November 1976, allowing City and County Departments to contract with			
10	private companies for specific services which can be performed for a lower cost than similar			
11	work by City and County employees (Charter Section 10.104.15); and			
12	WHEREAS, The services listed below have been previously approved outside			
13	contracts; and			
14	WHEREAS, The Controller has determined that a Purchaser's award of a contract for			
15	the services listed below to a private contractor will achieve substantial cost savings for the			
16	City; and			
17	WHEREAS, The City and County of San Francisco must reconcile a projected \$129			
18	million budget deficit for fiscal year 2013-14 with a Charter obligation to enact a balanced			
19	budget each fiscal year; and			
20	WHEREAS, The Mayor has determined that the state of the City's budget for fiscal			
21	year 2013-2014 as indicated herein has created an emergency situation justifying a			
22	Purchaser's award of a contract for employee and public parking management, information			
23	booth, security, and shuttle bus services at the San Francisco Airport; and			
24	WHEREAS, The Controller's certification, which confirms that said services can be			
25	performed at lower costs to the City and County by private contractor than by employees of
