11	(a)	Administra	tive Code, Section 2.81.2, requires the Purchaser to establish an	
12	outreach fui	utreach fund by withholding 10 percent of all revenue paid to each official newspaper. The		
13	outreach fund must be used for the purpose of placing weekly outreach advertisements in			
14	selected outreach periodicals, and outreach advertisements must be paid for solely by using			
15	monies from the outreach fund.			
16	(b)	Administra	tive Code, Section 10.100-40, establishes the Board of Supervisors	
17	Outreach Advertising Revenue Fund to receive monies withheld from payments to official			
18	newspapers for official advertising.			
19	(c)	The Purcha	aser and the Clerk of the Board of Supervisors anticipate that the
