STCC Inc. applied for a Type 48 Liquor License to operate the premises located at 3910 Geary Blvd. San Francisco 94118 on June 8, 2013.

- * Steven Phu Q Ly, the owner of STCC Inc. was cited and fined by California Department of Alcoholic Beverage Control on multiple occasions for allowing minors on the premises.
