Motion disapproving the determination by the Planning Department that the 39 Chattanooga Street project is categorically exempt from environmental review under the California Environmental Quality Act.

WHEREAS, the Planning Department determined that a proposal to construct an addition to an existing single-family residence without off-street parking to accommodate two dwelling units and two parking spaces at 39 Chattanooga Street ("Project") was categorically exempt from the California Environmental Quality Act ("CEQA") on or around June 13, 2005 ("determination"). A copy of the Certificate of Determination of Exemption/Exclusion from Environmental Review prepared by the Planning Department is on file with the Clerk of the Board of Supervisors in File No. 051320, and is incorporated by reference herein; and,

WHEREAS, By letter to the Clerk of the Board of Supervisors dated July 6, 2005, Susan Brandt-Hawley Law on behalf of Chattanooga Street/Golden Fireplug Historic District Friends ("Appellants"), filed an appeal of the Planning Department's determination that a project at 39 Chattanooga Street is categorically exempt from environmental review under the California Environmental Quality Act ("CEQA"), which the Clerk of the Board of Supervisors received on or around July 11, 2005; and,

WHEREAS, On August 9, 2005, this Board held a duly noticed public hearing to consider the appeal of the determination; and,

WHEREAS, This Board has reviewed and considered the determination, the appeal letter, the responses to concerns document that the Planning Department prepared, and public testimony; and,
