[Memorandum of Understanding]

IMPLEMENTING THE PROVISIONS OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE SUPERIOR COURT OF CALIFORNIA, COUNTY OF SAN FRANCISCO AND THE INTERNATIONAL FEDERATION OF PROFESSIONAL AND TECHNICAL ENGINEERS, LOCAL 21; RATIFYING ACTIONS PREVIOUSLY TAKEN.

Be it ordained by the People of the City and County of San Francisco:

- I. The Board of Supervisors hereby implements the provisions of the Memorandum of Understanding (MOU) between the Superior Court of California, County of San Francisco and the International Federation Of Professional And Technical Engineers, Local 21 (IFPTE, Local 21 or Local 21). The provisions so implemented are on file in the office of the Board of Supervisors.
- II. The General Fund of the City and County of San Francisco shall not be used to fund any of the salary increases or benefits referred to in the MOU. The City shall not be liable for any costs incurred in providing the wages and other benefits set forth in the MOU. The City's obligation under this ordinance shall be limited to administering health and retirement benefits and payroll processing. This paragraph shall not apply to the payment of wages and benefits for those positions covered by this ordinance which are specifically authorized and funded by the City budget.
- III. The City's obligations described herein are not intended to create a dual employer relationship.
 - IV. Retroactive Application.
