14 Section 2. The San Francisco Park Code is hereby amended by adding Section 12.38,  
15 to read as follows:

16 Sec. 12.38. LAKE MERCED BOAT STORAGE.

17 The fee for storing boats at the Lake Merced boathouse is \$25.00 per boat per month.


