7 **and authorizing the setting of specific penalties for parking violations through a**
8 **schedule of fines approved by ordinance of the Board of Supervisors.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Traffic Code is hereby amended by amending Sections
15 32, 32.1, 32.1.1 through 32.1.7, 32.1.9, 32.1.10, 32.1.11, 32.2, 32.2.1, 32.2.2, 32.2.3, 32.3,
16 32.3.1, 32.5, 32.6.1, 32.6.2, 32.6.3, 32.6.5, 32.6.6, 32.6.7, 32.6.8, 32.6.10, 32.6.11, 32.6.12,
17 32.6.13, 32.6.14, 32.6.16 through 32.6.29, 32.20, 210, and 412, to read as follows:

18 **Sec. 32. PARKING CONTROL.**

19 After a survey of parking conditions and a public hearing, the Board of Supervisors
20 shall designate by resolution those streets upon which parking is prohibited or restricted and
21 the time period applicable thereto, and those streets upon which stopping is prohibited. Such
22 designation shall be made as will promote uniformly efficient and safe use of such streets for
23 public street purposes.

24 The Department of Parking and Traffic shall erect, or cause to be erected,
25 appropriate signs giving notice thereof.

1 Any person violating any of the class of resolutions now or hereinafter in effect,
2 which are referred to in the following subsections of this Section, shall be guilty of an infraction
3 and upon conviction shall be subject to the penalties provided in that particular subsection
4 designating the class or type of violation and a schedule of fines approved by ordinance of the
5 Board of Supervisors as authorized under California Vehicle Code section 40203.5:

6 (a) Resolution or Ordinance prohibiting stopping on any street or alley:

7 (1) Within the Downtown Core Area: Fine of not less than \$40 or more than \$100;

8 (2) In all other areas: Fine of not less than \$20 or more than \$100.

9 (b) Resolution prohibiting parking on any street or alley: Fine of not less than \$20
10 or more than \$100.

11 (c) Resolution prohibiting parking on any street or alley for a longer period of time
12 than permitted in said resolution or Department Order (1) within the Downtown Core Area:
13 Fine of not less than \$20 or more than \$100; (2) in all other areas: Fine of not less than \$12 or
14 more than \$100; provided, however, that each and every hour that a vehicle remains parked
15 on any street or alley in violation of this subsection after issuance of the first citation therefor
16 shall constitute a separate and distinct offense and shall be punishable accordingly. The
17 provisions of this Subsection (c) shall not apply to violations of resolutions prohibiting parking
18 for a longer time than permitted in said resolution in parking meter zones established pursuant
19 to the provisions of Section 203 of this Code. Violations of such resolutions shall be punished
20 under the provisions of Section 210 of this Code.

21 (d) Notwithstanding any other provisions of this Code, any disabled person
22 entitled to and using a vehicle equipped with special attachments and devices to enable such
23 person to operate said vehicle shall be permitted to park such vehicle on any street or alley for
24 a period of time longer than prescribed by resolution enacted pursuant to Subsection (c)

1 hereof, during all hours when it is otherwise lawful for a vehicle to park continuously in the
2 same street or alley, and subject to the following requirements: Such disabled person shall
3 possess an identification card issued by the Chief of Police, certifying that he or she meets the
4 requirements of this Subsection and identifying the vehicle. The disabled person shall exhibit
5 such identification card when it is requested by any peace officer or Parking Control Officer.
6 Such vehicle shall bear a small and conspicuous sticker indicating the right to park as in this
7 Section provided, the sticker to be approved by the Chief of Police and to be at all times
8 displayed on the front windshield in the lower corner farthest removed from the driver's
9 position.

10 The permission granted hereunder to park on any street or alley specified in any
11 resolution adopted pursuant to Subsection (c) hereof for a greater length of time than the
12 period of time prescribed therein, shall not include any permission in relation to stopping or
13 parking on any streets or alleys where either is prohibited by resolution adopted pursuant to
14 Subsections (a) or (b) hereof or by the provisions of Sections 38.A, 38.B, 38.C and 38.D of
15 this Code.

16 **SEC. 32.1. PARKING CONTROL, PAVED AREAS IN CITY HALL BLOCK:**

17 *PENALTIES FOR VIOLATIONS.*

18 No person shall stop, park, or leave standing any vehicle, whether attended or
19 unattended, within the property lines of the block upon which the San Francisco City Hall is
20 situated, bounded by the westerly line of Polk Street, the northerly line of Grove Street, the
21 easterly line of Van Ness Avenue and the southerly line of McAllister Street, except (1) an
22 officer or employee of the City and County of San Francisco, having a permit therefor issued
23 by the Chief Administrative Officer and during the conduct by such officer or employee of the
24 business of the City and County, and (2) any person engaged in the loading or unloading of
25

1 freight upon or from a vehicle in the ramps or paved areas adjoining the northerly and
2 southerly entrances to the City Hall. Said Chief Administrative Officer shall have authority to
3 designate areas within the property lines of said block wherein various permittees shall be
4 permitted to park or leave vehicles, and no vehicles shall be parked or left in any area other
5 than so designated. *Violation of this Section is an infraction and any vehicle stopped, parked, or left*
6 *standing in any place prohibited by this Section is an obstruction to the free use of property and a*
7 *nuisance within the meaning of Part III of the Civil Code of California relating to nuisances and the*
8 *abatement thereof.*

9 **SEC. 32.1.1. PARKING CONTROL, MAIN LIBRARY PROPERTY; ~~PENALTIES FOR~~**
10 **~~VIOLATION.~~**

11 No person shall stop, park, or leave standing any vehicle, whether attended or
12 unattended, within the property lines of the block upon which the San Francisco Main Library
13 is situated, bounded by Larkin, Grove, Hyde, and Fulton Streets, except (1) an officer or
14 employee of the City and County of San Francisco, having a permit therefor issued by the City
15 Librarian and during the conduct by such officer or employee of the business of the City and
16 County, and (2) any person engaged in the loading or unloading of freight upon or from a
17 vehicle in the garage or paved areas within said San Francisco Main Library property lines.
18 Said City Librarian shall have authority to designate areas within the property lines of the
19 block wherein various permittees shall be permitted to park or leave vehicles, and no vehicles
20 shall be parked or left in any area other than so designated. *Violation of this Section is an*
21 *infraction and any vehicle stopped, parked, or left standing in any place prohibited by this Section is an*
22 *obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of the*
23 *Civil Code of California relating to nuisances and the abatement thereof.*

1 **SEC. 32.1.2. PARKING CONTROL, EUREKA VALLEY AND WESTERN ADDITION**
2 **BRANCH LIBRARIES; ~~PENALTIES FOR VIOLATION.~~**

3 Parking within the property lines of the Eureka Valley Branch Library, 3555 16th Street,
4 and Western Addition Branch Library, 1550 Scott Street, shall be restricted to one hour at all
5 times when these branches are open to the public. This restriction shall not be applicable to
6 the following permittees designated by the Librarian as follows: (1) an officer or employee of
7 the City and County of San Francisco, having a permit therefor issued by the Librarian and
8 during the conduct by such officer or employee of the business of the City and County of San
9 Francisco, and (2) any person engaged in the loading or unloading of freight upon or from a
10 vehicle. The Librarian shall have the authority to designate areas within the property lines of
11 said branch libraries wherein various permittees shall be permitted to park or leave vehicles,
12 and no vehicles shall be parked or left in any area other than so designated.

13 No person shall stop, park, or leave standing any vehicle, whether attended or
14 unattended, within the property lines of the areas upon which the Eureka Valley Branch
15 Library and the Western Addition Branch Library are situated when said branches are closed
16 to the public. ~~Violation of this paragraph is an infraction and any vehicle stopped, parked, or left~~
17 ~~standing within the parking areas of these branch libraries when the library is closed, is an obstruction~~
18 ~~to the free use of property and a nuisance within the meaning of Division 4, Part III of the Civil Code of~~
19 ~~California relating to nuisances and the abatement thereof.~~

20 **SEC. 32.1.3. PARKING CONTROL, DEPARTMENT OF SOCIAL SERVICES**
21 **PROPERTY; ~~PENALTIES FOR VIOLATION.~~**

22 No person shall stop, park, or leave standing any vehicle, whether attended or
23 unattended, within the property lines of the Department of Social Services building, 150 Otis
24 Street (Lot 7, Block 3513), and the vacant area situate at the gore corner of Mission and Otis
25

1 Streets and Duboce Avenue (portion of Lot 6A, Block 3512), except (1) an officer or employee
2 of the City and County of San Francisco having a permit therefor issued by the General
3 Manager of the Department of Social Services and during the conduct by such officer or
4 employee of the business of the City and County, and (2) any person engaged in the loading
5 or unloading of passengers or freight upon or from a vehicle within said property lines. Said
6 General Manager shall have authority to designate areas within said property lines wherein
7 various permittees shall be permitted to park or leave vehicles, and no vehicles shall be
8 parked or left in any area other than so designated. *Violation of this Section is an infraction and*
9 *any vehicle stopped, parked, or left standing in any place prohibited by this Section is an obstruction to*
10 *the free use of property and a nuisance within the meaning of Division 4, Part III of the Civil Code of*
11 *California relating to nuisances and the abatement thereof.*

12 **SEC. 32.1.4. PARKING CONTROL ON SAN FRANCISCO HOUSING AUTHORITY**
13 **PROPERTY; ~~PENALTIES FOR VIOLATION.~~**

14 No person shall stop, park or leave standing any vehicle, whether attended or
15 unattended, within the property lines of the following listed San Francisco Housing Authority
16 property: CAL 1-1 (Holly Courts), CAL 1-2 (Potrero Terrace), CAL 1-3 (Sunnydale), CAL 1-4
17 (Valencia Gardens), CAL 1-5 (Bernal Dwellings), CAL 1-8 (Westside Courts), CAL 1-9 (Harbor
18 Slope), CAL 1-10 (Potrero Annex), CAL 1-11 (North Beach), CAL 1-15 (Ping Yuen), CAL 1-16
19 (Alemany), CAL 1-17 (A) [Hunters Point (A)], CAL 1-17 (B) [Hunters Point (B)], CAL 1-18(1)
20 (J.F. Kennedy Towers), CAL 1-18(2) (Yerba Buena Plaza), CAL 1-18(3) (Hunters View), CAL
21 1-18(4) (Alice Griffith), CAL 1-18(5) (Yerba Buena Annex), CAL 1-18(6) (Ping Yuen North),
22 CAL 1-18(7) (Hayes Valley), CAL 1-18(10) (Woodside Gardens), CAL 1-19-1(1) (990 Pacific
23 Avenue), CAL 1-20 (3850 18th Street), CAL 1-21 (320-330 Clementina), CAL 1-23 (350 Ellis
24 Street), CAL 1-28 (666 Ellis Street), CAL 1-30 (345 Hermann Street, 77 Coleridge Street, 105
25

1 Lundy's Lane), CAL 1-31 (25 Sanchez Street), CAL 1-32 (1760 Bush Street), CAL 1-33 (275
2 Thrift Street), CAL 1-34 (4101 Noriega Street, 220 Randolph Street, 363 Noe Street), except
3 (1) an officer of the City and County of San Francisco or employee of the San Francisco
4 Housing Authority on official business, (2) other authorized persons to be determined by the
5 Executive Director of the San Francisco Housing Authority, (3) permittees of the San
6 Francisco Housing Authority, and (4) any person engaged in loading or unloading of
7 passengers or freight upon or from a vehicle in a paved area within the San Francisco
8 Housing Authority property designated above. Said Executive Director of the San Francisco
9 Housing Authority shall have authority to designate areas where various permittees shall be
10 entitled to park or leave vehicles, and no vehicle shall be parked, or left in any area other than
11 so designated. *Violation of this Section is an infraction, and any vehicle stopped, parked, or left
12 standing in any place prohibited by this Section is an obstruction to the free use of property and a
13 nuisance within the meaning of Division 4, Part III, of the Civil Code of California relating to
14 nuisances and the abatement thereof.*

15 Pursuant to the provisions of Section 40 of this Code, the provisions of this Section
16 shall not be effective until signs giving notice of said provisions are posted at the locations
17 specified in Section 42 of this Code.

18 **SEC. 32.1.5. PARKING CONTROL, PAVED AREA OF OFF-STREET MUNICIPAL**
19 **RAILWAY TERMINALS.**

20 No person shall stop, park or leave standing any vehicle, whether attended or
21 unattended, within the property lines of the Municipal Railway's terminals situated at the
22 following locations: (1) Ferry Loop bounded by Steuart Street, Mission Street, The
23 Embarcadero and a line approximately 260 feet northerly parallel to Mission Street, (2) Myra
24 Way at Dalewood Way, (3) Cabrillo Street at La Playa, and (4) Phelan Loop at Ocean
25

1 Avenue, except San Francisco Municipal Railway transit vehicles. *Violation of this Section is an*
2 *infraction and any vehicle stopped, parked or left standing in any place prohibited by this Section is an*
3 *obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of the*
4 *Civil Code of California relating to nuisance and the abatement thereof.*

5 **SEC. 32.1.6. PARKING CONTROL, CASTRO STREET STATION PLAZA;**
6 ***PENALTIES FOR VIOLATION.***

7 No person shall stop, park, or leave standing any vehicle, whether attended or
8 unattended, within the Castro Street Station Plaza approximately bounded by the south
9 curblineline of Market Street on the north, Castro Street on the east, the south property line of
10 Market Street on the south and Collingwood Street on the west, except for motorists gaining
11 access to or from the private garages on the south side of Market Street between Castro and
12 Collingwood Streets. The Department of Parking and Traffic shall erect, or cause to be
13 erected, appropriate signs giving notice thereof. *Violation of this Section is an infraction and any*
14 *vehicle stopped, parked, or left standing in any place prohibited by this Section is an obstruction to the*
15 *free use of property and a nuisance within the meaning of Division 4, Part III of the Civil Code of*
16 *California relating to nuisance and the abatement thereof.*

17 **SEC. 32.1.7. PARKING CONTROL, SAN FRANCISCO UNIFIED SCHOOL DISTRICT**
18 **PROPERTY; *PENALTIES FOR VIOLATION.***

19 No person shall stop, park, or leave standing any vehicle, whether attended or
20 unattended, within the property lines of Block 815 upon which the San Francisco Unified
21 School District building is situated, and on the parking lot located on the westerly portion of
22 Block 762, except (1) an officer or employee of the City and County of San Francisco, having
23 a permit therefor issued by the Superintendent of Schools and during the conduct by such
24 officer or employee of the business of the City and County, and (2) any person engaged in the
25

1 loading and unloading of passengers or freight upon or from a vehicle within said property
2 lines. Said Superintendent shall have authority to designate areas where various permittees
3 shall be entitled to park or leave vehicles and no vehicle shall be parked or left in any area
4 other than as so designated. *Violation of this Section is an infraction and any vehicle stopped,*
5 *parked, or left standing in any place prohibited by this Section is an obstruction to the free use of*
6 *property and a nuisance within the meaning of Division 4, Part III, of the Civil Code of California*
7 *relating to nuisances and the abatement thereof.*

8 **SEC. 32.1.9. PARKING CONTROL, PROPERTY UNDER THE JURISDICTION AND**
9 **CONTROL OF THE SAN FRANCISCO PUBLIC UTILITIES COMMISSION AND ITS**
10 **DEPARTMENTS AND BUREAUS; ~~PENALTIES FOR VIOLATION.~~**

11 No person shall stop, park, or leave standing any vehicle, whether attended or
12 unattended, within the property lines of any facility under the jurisdiction and control of the
13 San Francisco Public Utilities Commission and its departments and bureaus, except (1) an
14 officer or employee of the City and County of San Francisco, having a permit therefor issued
15 by the General Manager of Public Utilities and during the conduct by such officer or employee
16 of the business of the City and County, and (2) any person engaged in loading and unloading
17 of passengers or freight upon or from a vehicle within such property lines, and (3) any person
18 conducting any business with the City and County of San Francisco when such business must
19 be conducted within any facility to which the property above referenced is attached. The
20 General Manager shall have the authority to designate areas where various permittees shall
21 be entitled to leave vehicles and no vehicle shall be parked or left in the area other than as so
22 designated. *Violation of this Section is an infraction and any vehicle stopped, parked or left standing*
23 *in any place prohibited by this Section is an obstruction to the free use of property and a nuisance*
24
25

1 *within the meaning of Division 4, Part III of the Civil Code of California relating to nuisances and the*
2 *abatement thereof.*

3 When the General Manager has designated a permit area, he shall have posted a sign
4 giving notice that pursuant to California Vehicle Code Section 22651, any vehicles which do
5 not have permits parked or left standing in that area shall be subject to removal.

6 **SEC. 32.1.10. PARKING CONTROL, PORTIONS OF WASHINGTON, MASON AND**
7 **JACKSON STREETS; ~~PENALTIES FOR VIOLATION.~~**

8 No person shall stop, park, or leave standing any vehicle, whether attended or
9 unattended, at any time, on both sides of Washington Street from Mason Street to a point 210
10 feet westerly, south side of Jackson Street from Mason to a point 210 feet westerly, and the
11 west side of Mason Street from Jackson to Washington, except an officer or employee of the
12 City and County of San Francisco having a permit therefor issued by the San Francisco Public
13 Utilities Commission and during the conduct of such officer or employee of the business of the
14 City and County. Said Public Utilities Commission shall have authority to designate areas
15 where various permittees shall be entitled to park or leave vehicles and no vehicles shall be
16 parked or left in any area other than as so designated. *Violation of this Section is an infraction*
17 *and any vehicles stopped, parked, or left standing in any place prohibited by this Section is an*
18 *obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of the*
19 *Civil Code of California relating to nuisance and the abatement thereof.*

20 **SEC. 32.1.11. PARKING CONTROL, PROPERTY UNDER THE JURISDICTION AND**
21 **CONTROL OF THE SAN FRANCISCO DEPARTMENT OF PUBLIC WORKS AND ITS**
22 **BUREAUS AND DIVISIONS; ~~PENALTIES FOR VIOLATION.~~**

23 The Director of Public Works shall have the authority to designate areas, under the
24 jurisdiction and control of the San Francisco Department of Public Works and its Bureaus and
25

1 Divisions, where no vehicle shall be parked or left in the area so designated. *Violation of this*
2 *Section is an infraction and any vehicle stopped, parked or left standing in any place prohibited by this*
3 *Section is an obstruction to the free use of property and a nuisance within the meaning of Division 4,*
4 *Part III of the Civil Code of California relating to nuisances and the abatement thereof.*

5 When the Director of Public Works has designated such a restricted area, he shall
6 have posted a sign giving notice that pursuant to California Vehicle Code Section 22651, any
7 vehicles parked or left standing in the area shall be subject to removal.

8 **SEC. 32.2. PARKING CONTROL, SAN FRANCISCO GENERAL HOSPITAL**
9 **PROPERTY AND AREA; ~~PENALTIES FOR VIOLATION.~~**

10 No person shall stop, park, or leave standing any vehicle, whether attended or
11 unattended, within the property lines of San Francisco General Hospital, including the block
12 bounded by 22nd Street, Vermont Street, 23rd Street, and Potrero Avenue and the area
13 bounded on three sides by San Bruno Avenue, 22nd Street, and Potrero Avenue and
14 extending northward approximately 816 feet from 22nd Street, said area being occupied in
15 part by the Maternity and Psychiatric buildings of San Francisco General Hospital, and also
16 including the north side of 22nd Street from Potrero Avenue to San Bruno Avenue, the south
17 side of 22nd Street from Potrero Avenue to Vermont Street, the west side of San Bruno
18 Avenue north of 22nd Street, and both sides of Vermont Street between San Bruno Avenue
19 and 23rd Street, said area being adjacent to and servicing San Francisco General Hospital,
20 except (1) an officer or employee of the City and County of San Francisco or an employee or
21 staff member of the Stanford University or University of California Medical Schools or any
22 other person having an unexpired permit therefor authorized by the Executive Administrator of
23 San Francisco General Hospital, and (2) any person engaged in the loading or unloading of
24 passengers or freight upon or from a vehicle in a paved area within said San Francisco
25

1 General Hospital property lines. Said Executive Administrator shall have authority to
2 designate areas where various permittees shall be entitled to park or leave vehicles and no
3 vehicle shall be parked or left in any area other than as so designated. *Violation of this Section*
4 *is an infraction and any vehicle stopped, parked, or left standing in any place prohibited by this Section*
5 *is an obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of*
6 *the Civil Code of California relating to nuisances and the abatement thereof.*

7 **SEC. 32.2.1. PARKING CONTROL, EUREKA-NOE DISTRICT HEALTH CENTER**
8 **NO. 1 PROPERTY; ~~PENALTIES FOR VIOLATION.~~**

9 No person shall stop, park, or leave standing any vehicle, whether attended or
10 unattended, within the property lines of the area upon which the Eureka-Noe District Health
11 Center No. 1 is situated on 17th Street between Pond and Prosper Streets (Lot 49, Block
12 3564), except (1) an officer or employee of the City and County of San Francisco, having a
13 permit therefor issued by the District Health Officer and during the conduct by such officer or
14 employee of the business of the City and County, and (2) any person engaged in the loading
15 and unloading of passengers or freight upon or from a vehicle in a paved area within said
16 Eureka-Noe District Health Center No. 1 property lines. Said District Health Officer shall have
17 authority to designate areas where various permittees shall be entitled to park or leave
18 vehicles and no vehicle shall be parked or left in any area other than as so designated.
19 *Violation of this Section is an infraction and any vehicle stopped, parked, or left standing in any place*
20 *prohibited by this Section is an obstruction to the free use of property and a nuisance within the*
21 *meaning of Division 4, Part III of the Civil Code of California relating to nuisances and the abatement*
22 *thereof.*

23 **SEC. 32.2.2. PARKING CONTROL, SUNSET-RICHMOND DISTRICT HEALTH**
24 **CENTER NO. 5; ~~PENALTIES FOR VIOLATION.~~**

1 No person shall stop, park, or leave standing any vehicle, whether attended or
2 unattended, within the property lines of the area upon which the Sunset-Richmond District
3 Health Center No. 5 is situated at 1351 Twenty-Fourth Avenue (Lot 7, Block 1779), except (1)
4 an officer or employee of the City and County of San Francisco having a permit therefor
5 issued by the District Health Officer and during the conduct by such officer or employee of the
6 business of the City and County, and (2) any person engaged in the loading or unloading of
7 passengers or freight upon or from a vehicle in a paved area within said property lines. Said
8 District Health Officer shall have authority to designate areas where various permittees shall
9 be permitted to park or leave vehicles, and no vehicle shall be parked or left in any area other
10 than so designated. *Violation of this Section is an infraction and any vehicle stopped, parked, or left*
11 *standing in any place prohibited by this Section is an obstruction to the free use of property and a*
12 *nuisance within the meaning of Division 4 Part III of the Civil Code of California relating to nuisances*
13 *and the abatement thereof.*

14 **SEC. 32.2.3. PARKING CONTROL, NORTH EAST DISTRICT HEALTH CENTER NO.**
15 **4 PROPERTY; ~~PENALTIES FOR VIOLATION.~~**

16 No person shall stop, park, or leave standing any vehicle, whether attended or
17 unattended, within the property lines of the area upon which the North East District Health
18 Center No. 4 is situated on Mason Street at Broadway, except (1) an officer or employee of
19 the City and County of San Francisco, having a permit therefor issued by the Director of
20 Public Health or District Health Officer and during the conduct by such officer or employee of
21 the business of the City and County, and (2) any person engaged in the loading or unloading
22 of passengers or freight upon or from a vehicle in a paved area within said North East District
23 Health Center No. 4 property lines. Said District Health Officer shall have authority to

6 unattended, on the east side of South Van Ness Avenue, from 12th Street to 110 feet
7 southerly (110-foot zone), from 6:00 a.m. to 8:00 p.m., Monday through Friday, except official
8 vehicles displaying a valid permit issued by the State of California's Department of
9 Corrections authorizing parking in such zones. The permit exceptions under this Section shall
10 not apply when parking prohibition regulations for street-cleaning purposes are in effect.

11 *Violation of this Section is an obstruction to the free use of property and a nuisance within the meaning*

15 No person shall stop, park, or leave standing any vehicle, whether attended or
16 unattended within the property lines of the area upon which the San Francisco Hall of Justice
17 is situated, bounded by the northwesterly side of Brunt Street, the southwesterly side of
18 Harriet Street, and southeasterly side of the right-of-way of the James Lick Freeway, and the
19 northeasterly side of Seventh Street, except (1) those vehicles having a permit to park therein
20 issued by the Chief of Police and being official City-owned vehicles under the jurisdiction of
21 the Police Department, Sheriff's Department, District Attorney's Office, Public Defender's
22 Office, Coroner's Department, Adult Probation Department, Office of Emergency Services,
23 and (2) an officer or employee of the City and County of San Francisco having a permit

8 **SEC. 210. PENALTIES FOR VIOLATIONS.**

9 (a) Except as provided in Subsection (b) below, any person violating any of the
10 provisions of this Article shall be guilty of an infraction and upon conviction thereof shall be
11 punished by a fine of not less than \$15 nor more than \$50 for each offense as set forth by
12 ordinance of the Board of Supervisors. Each such person shall be guilty of a separate and
13 distinct offense for each and every hour of any unauthorized occupancy of a parking meter
14 zone in violation of Section 202 of this Article after the issuance of the first citation therefor
15 and shall be punished accordingly.

16 (b) Any person violating Section 202.1 shall be guilty of an infraction and upon
17 conviction thereof shall be punished by a fine of not less than \$20 nor more than \$50 for each
18 offense as set forth by ordinance of the Board of Supervisors. Each such person shall be guilty of a
19 separate and distinct offense for each and every hour of any unauthorized occupancy of a
20 parking meter zone in violation of Section 202.1 of this Article after the issuance of the first
21 citation therefor and shall be punished accordingly.

22 **SEC. 412. PENALTY PROVISIONS.**

23 (a) It shall be unlawful and a violation of this Article, unless expressly provided to the
24 contrary herein, for any person to stand or park a motor vehicle of a gross weight exceeding
25

1 50 pounds for a period exceeding the time limitations established pursuant hereto. Said
2 violation shall be an infraction punishable by (1) a fine not exceeding \$50 for a first violation;
3 (2) a fine not exceeding \$100 for a second violation of the same ordinance within one year;
4 and (3) a fine not exceeding \$250 for each additional violation of the same ordinance within
5 one year as set forth by ordinance of the Board of Supervisors.

6 (b) It shall be unlawful and a violation of this Article for a person to falsely
7 represent that he or she is eligible for a parking permit or to furnish false information in an
8 application therefor submitted to either the institution or the Department of Parking and Traffic.


9 (c) It shall be unlawful and a violation of this Article for a person holding a valid
10 parking permit issued pursuant hereto to permit the use or display of such permit on a motor
11 vehicle other than that for which the permit is issued. Such conduct shall constitute an
12 unlawful act and violation of this Article both by the person holding the valid parking permit
13 and the person who so uses or displays the permit on a motor vehicle other than that for
14 which it is issued.

15 (d) It shall be unlawful and a violation of this Article for a person to copy, produce
16 or otherwise bring into existence a facsimile or counterfeit parking permit or permits without
17 written authorization from the Director of Parking and Traffic. It shall further be unlawful and a
18 violation of this Article for a person to knowingly use or display a facsimile or counterfeit
19 parking permit in order to evade time limitations on parking applicable in a carpool permit
20 parking area. Upon conviction thereof, a person shall be punishable by a fine not exceeding
21 \$500 or by imprisonment for a period not exceeding 6 months, or both.

22 (e) The violations as set forth in the preceding subsections (b), and (c) and (d)
23 shall be infractions punishable by a fine not exceeding \$500.


