19 Illinois, Eastern Division on the terms and conditions specified in that certain Cure Stipulation

20 Agreement on file with the Clerk of the Board (file no. 040321) (the

21 **“Cure Stipulation Agreement”);**

22 Section 2. The Cure Stipulation Agreement and the actions contemplated thereby

23 are hereby approved.

24 Section 3. That the Airport Director be and hereby is authorized to take such other

25 actions as are necessary and appropriate in furtherance of this ordinance, including the


