Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Health Code is hereby amended by adding Section 3204 to read as follows:

SEC, 3204, APPLICATION FOR MEDICAL CANNABIS DISPENSARY PERMIT.

(a) Every applicant for a medical cannabis dispensary permit shall file an application with the Director upon a form provided by the Director and pay a non-refundable permit application fee of \$61106691.00 to cover the costs to all City departments of investigating and processing the application and any applicable surcharges, exclusive of filing fees for appeals before the Board of Appeals.

Section 2. The San Francisco Business and Tax Regulations Code is hereby amended by adding Section 249.17 to read as follows:

SEC. 249.17. MEDICAL CANNABIS DISPENSARY LICENSE FEE.

SUPERVISOR MIRKARIMI **BOARD OF SUPERVISORS**

Every person, firm or corporation engaged in operating a medical cannabis dispensary shall pay an annual license fee of \$2,1823,100.00 to the Tax Collector to-cover the costs of annual inspections, enforcement and other costs to the City.
