9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. The San Francisco Administrative Code is hereby amended by amending Section 10.100-18,
11	to read as follows:
12	Sec. 10.100-18 AIRPORT PROMOTION AND EVENT FUND AIRPORT TERMINAL 2 PROMOTION FUND
13	(a) Establishment of Fund. The Airport Promotion and Special Event Account is hereby established as a
14	category six fund for the purpose of receiving all donations of money, property and personal services which may be offered
15	to the City and County of San Francisco through the Airport for the uses described in (b).
16	(b) Use of the Fund. Money, property and personal services comprising the Airport Promotion and Event
17	Account shall be used and expended for such purposes as will be determined in the sole discretion of the Airport
18	Commission to assist in the business promotion, and special event and community outreach activities associated with the
19	inaugural of the San Francisco International Airport Master Plan Program and projects related to said program.
20	(c) Exceptions to Fund Category. Money, property and personal services comprising the Airport Promotion
21	and Event Account shall be expended for such purposes as will be determined in the sole discretion of the Airport
22	Commission. Any unexpended balances remaining in the Airport Promotion and Event Account when it expires on
23	September 30, 2001 shall be deposited in the City's General Fund.

- 1 (d) Administration of Fund. The Airport Director shall submit to the Board of Supervisors and the Budget
- 2 Analyst on a bi monthly basis written reports of revenues to and expenditures from the Airport Promotion and Event
- 3 Account during the bi-monthly period covered by the report. This fund shall expire on September 30, 2001.
- 4 Establishment of the Airport Terminal 2 Promotion Fund. The Airport Terminal 2 Promotion Fund is (a)
- 5 hereby established as a category six fund for the purpose of receiving all donations of money, property and personal
- 6 services which may be offered to the City and County of San Francisco through the Airport for the uses described in
- 7 subsection (b).
- 8 Use of the Airport Terminal 2 Promotion Fund. Money, property and personal services comprising the (b)
- 9 Fund shall be used and expended for such purposes as will be determined in the sole discretion of the Airport Commission
- 10 to assist in the business promotion, and special event and community outreach activities associated with the opening of the
- 11 newly renovated Terminal 2 of the San Francisco International Airport.
- 12 Exceptions to Fund Category. Money, property and personal services comprising the Airport Terminal 2 (c)
- 13 Promotion Fund shall be expended for such purposes as will be determined in the sole discretion of the Airport
- 14 Commission. Any unexpended balances remaining in the Fund when it expires on December 31, 2011 shall be deposited in
- 15 the City's General Fund.
- 16 (d) Administration of Fund. The Airport Director shall submit to the Board of Supervisors and the Budget
- 17 Analyst on a bi-monthly basis written reports of revenues to and expenditures from the Airport Terminal 2 Promotion Fund
- 18 during the bi-monthly period covered by the report. This fund shall expire on December 31, 2011.
