10	Be it ordained by the People of the City and County of San Francisco:
11	Section 1. The Planning Department has determined that the actions contemplated in
12	this ordinance comply with the California Environmental Quality Act (California Public
13	Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the
14	Board of Supervisors in File No and is incorporated herein by reference.
15	
16	Section 2. The Park Code is hereby amended by adding Section 3.21, to read as
17	follows:
18	SEC. 3.21. HOURS OF OPERATION.
19	(a) Persons may enter and use any park from 5:00 a.m. to midnight daily, provided that (1) the
20	Department may set different hours in a permit, contract or lease, and (2) whenever a threat to public
21	health or safety exists in any park resulting from any natural cause, explosion, accident or any other
22	cause, or by riot or unlawful assembly or activity, the General Manager may close the park or any part
23	thereof to the public for such duration as he or she deems necessary to ensure the safety and well-being
24	of the public.
25	

1	(b) No person shall enter or remain in any park without the permission of the Department
2	outside of the hours open to the public as specified in subsection (a), except that in the case of Balboa
3	Park, Golden Gate Park, Lincoln Park, and McLaren Park, persons may use a vehicle (including but
4	not limited to a car, truck, bicycle and motorcycle) on the roadway(s) in those parks or walk on paved
5	sidewalks immediately adjacent to such roadways, at any time for purposes of traversing the park only.
6	A violation of this subsection (b) shall be subject to the penalties set forth in Park Code Article 10.
7	(c) The Department shall post the hours for each park (1) at the park in a location designed to
8	provide notice to members of the public, and (2) on the Department's website.
9	
10	Section 3. Effective Date. This ordinance shall become effective 30 days after
11	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
12	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
13	of Supervisors overrides the Mayor's veto of the ordinance.
