[Affirm certification of San Francisco Marina Renovation FEIR ]

Motion affirming the certification by the Planning Commission of the Final Environmental Impact Report for the San Francisco Marina Renovation Project.

WHEREAS, The San Francisco Recreation and Park Commission (the "Project Sponsor") is proposing to renovate the San Francisco Marina, located north of Marina Boulevard between Lyon and Laguna Streets (the "Project"); and

WHEREAS, The Project Sponsor applied for environmental review to the Planning Department for the City and County of San Francisco (the "Department") (City Planning File No. 2002.1129E) and on December 27, 2003, the Planning Department published a preliminary negative declaration; and

WHEREAS, Following several appeals, the Department determined that an Environmental Impact Report ("EIR") was required and provided public notice of that determination by publication in a newspaper of general circulation on October 9, 2004; and

WHEREAS, On September 6, 2005, the Department published the Draft Environmental Impact Report ("DEIR") for the Project; and

WHEREAS, On October 6, 2005 and January 12, 2006, the Planning Commission for the City and County of San Francisco (the "Planning Commission") held duly noticed public hearings on the DEIR, at which time opportunity for public comment was received on the DEIR, and written comments were received through January 20, 2006; and

WHEREAS, The Department prepared responses to comments received at the public hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text of the DEIR and published a Draft Summary of Comments and Responses on September 28, 2006; and

WHEREAS, The Department prepared a Final Environmental Impact Report ("FEIR") for the Project, consisting of the DEIR, any consultations and comments received during the review process, any additional information that became available and the Draft Summary of Comments and Responses, all as required by law; and

WHEREAS, On January 11, 2007, the Planning Commission reviewed and considered the FEIR and, by Motion No. 17357, found that the contents of said report and the procedures through which the FEIR was prepared, publicized and reviewed complied with the provisions of the California Environmental Quality Act ("CEQA"), the State CEQA Guidelines and Chapter 31 of the San Francisco Administrative Code; and

WHEREAS, By Motion No. 17357, the Planning Commission found the FEIR to be adequate, accurate and objective, reflected the independent judgment and analysis of the Department and the Commission and that the Summary of Comments and Responses contained no significant revisions to the DEIR, adopted findings relating to significant impacts associated with the Project and certified the completion of the FEIR in compliance with CEQA and the State CEQA Guidelines; and

WHEREAS, On January 18, 2007, the Recreation and Park Commission adopted CEQA Findings and approved the Marina Renovation Project; and

WHEREAS, On January 31, 2007, Howard Strassner, on behalf of San Francisco Group of the Sierra Club filed an appeal of the FEIR with the Clerk of the Board of Supervisors; and

WHEREAS, The Board of Supervisors held a public hearing on February 27, 2007, to review the decision by the Planning Commission to certify the FEIR; and

WHEREAS, the FEIR files and all correspondence and other documents have been made available for review by the Board of Supervisors, the Planning Commission and the

public; these files are available for public review by appointment at the Department offices at 1660 Mission Street, and are part of the record before the Board of Supervisors; and

WHEREAS, this Board has reviewed and considered the FEIR and heard testimony and received public comment regarding the adequacy of the FEIR; now, therefore, be it

MOVED, That this Board of Supervisors hereby affirms the decision of the Planning Commission in its Motion No. 17357 to certify the FEIR and finds the FEIR to be complete, adequate and objective and reflecting the independent judgment of the City and in compliance with CEQA and the State CEQA Guidelines.
