[Affirming certification of Market and Octavia Area Plan FEIR]

Motion affirming the certification by the Planning Commission of the Final Environmental Impact Report for the Market and Octavia Area Plan.

WHEREAS, The San Francisco Planning Commission (the "Commission") is proposing to adopt the Market and Octavia Area Plan through amendments to the General Plan, Planning Code, Zoning Map and Western Addition A-2 Redevelopment Plan and adoption of urban design guidelines for an area generally located to the west of the City's downtown area and including portions of Civic Center, Hayes Valley, Western Addition, South of Market, Inner Mission, The Castro, Duboce Triangle, Eureka Valley and Upper Market neighborhoods of San Francisco (the "Project"); and

WHEREAS, the San Francisco Planning Department (the "Department") initiated environmental review by filing an environmental evaluation application on March 26, 2003 (City Planning File No. 2003.0347E); and

WHEREAS, The Department determined that an Environmental Impact Report ("EIR") was required and provided public notice of that determination by publication in a newspaper of general circulation on January 23, 2004; and

WHEREAS, On June 25, 2005, the Department published the Draft Environmental Impact Report ("DEIR") for the Project; and

WHEREAS, On July 28, 2005, the Commission held a duly noticed public hearing on the DEIR, at which time the Commission provided an opportunity for and received public comments, and the Commission received written comments through August 23, 2005; and

WHEREAS, The Department prepared responses to comments received at the public hearing on the DEIR and submitted in writing to the Department, prepared revisions to the text

of the DEIR and published a Draft Summary of Comments and Responses on September 26, 2006; and

WHEREAS, A Final Environmental Impact Report ("FEIR") for the Project was prepared by the Department, consisting of the DEIR, any consultations and comments received during the review process, any additional information that became available and the Draft Summary of Comments and Responses, all as required by law; and

WHEREAS, On April 5, 2007, the Commission reviewed and considered the FEIR and, by Motion No. 17406, found that the contents of said report and the procedures through which the FEIR was prepared, publicized and reviewed complied with the provisions of the California Environmental Quality Act (CEQA), the State CEQA Guidelines and Chapter 31 of the San Francisco Administrative Code; and

WHEREAS, By Motion No. 17406, the Commission found the FEIR to be adequate, accurate and objective, reflected the independent judgment and analysis of the Department and the Commission and that the Summary of Comments and Responses contained no significant revisions to the DEIR, adopted findings relating to significant impacts associated with the Project and certified the completion of the FEIR in compliance with CEQA and the State CEQA Guidelines; and

WHEREAS, On April 5, 2007, by Motion No. 17407 and Resolutions 17408, 17409 and 17410, the Commission adopted CEQA Findings, including a statement of overriding considerations and mitigation measures and a Mitigation Monitoring and Reporting Program, and approved and recommended to the Board of Supervisors amendments to the General Plan, Planning Code and Zoning Map required to implement the Market and Octavia Area Plan; and

WHEREAS, On April 25, 2007, Martin Hamilton, on behalf of New College of California, F. Joseph Butler, on behalf of the San Francisco Preservation Consortium and Mary Miles, on

behalf of the Coalition for Adequate Review, filed an appeal of the FEIR with the Clerk of the Board of Supervisors; and

WHEREAS, The Board of Supervisors held a public hearing on May 22, 2007, to review the decision by the Commission to certify the FEIR; and

WHEREAS, the FEIR files and all correspondence and other documents have been made available for review by the Board of Supervisors, the Commission and the public; these files are available for public review by appointment at the Planning Department offices at 1650 Mission Street, and are part of the record before the Board of Supervisors; and

WHEREAS, this Board has reviewed and considered the FEIR and heard testimony and received public comment regarding the adequacy of the FEIR; now, therefore, be it

MOVED, That this Board of Supervisors hereby affirms the decision of the Commission in its Motion No. 17406 to certify the FEIR and finds the FEIR to be complete, adequate and objective and reflecting the independent judgment of the City and in compliance with CEQA and the State CEQA Guidelines.
