

1 [Accept-Expend Federal Grant – Special Emphasis Victim Assistance Program - Homicide]

3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$110,000**
5 **through the California Governor’s Office of Emergency Services, Criminal Justice**
6 **Programs Division, for the operation of a program entitled “Special Emphasis Victim**
7 **Assistance Program—Homicide.”**

9 WHEREAS, The City and County of San Francisco desires to continue a certain project
10 designated the San Francisco Special Emphasis Victim Assistance Program : Homicide, to
11 be funded in part from funds made available through the Governor’s Office of Emergency
12 Services, Criminal Justice Programs Division (CJPD); and,

13 WHEREAS, CJPD requires that the City and County of San Francisco, through the
14 Office of the District Attorney, provide no less than a twenty percent in-kind match for the
15 grant; and

16 WHEREAS, All positions supported by these funds shall be coded “G” in the District
17 Attorney’s budget; and,

18 WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant
19 budget; now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of the City
21 and County of San Francisco to retroactively accept and expend funds from CJPD for the
22 purposes of special emphasis victim assistance program: homicide; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
24 indirect costs in the grant budget; and be it

1 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
2 the City and County of San Francisco the necessary Grant Award Agreements for purposes of
3 special emphasis victim assistance program: homicide purposes, including any extensions,
4 augmentations or amendments thereof; and be it


5 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
6 execute, deliver and perform, in the name of the City and County of San Francisco, all
7 applications, contracts, agreements, amendments and payment requests necessary for the
8 purpose of securing Special Emphasis Victim Assistance Program: Homicide grant funds and
9 to implement and carry out the purposes specified in the applicable grant application; and be it

10 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
11 Award Agreement, including civil court actions for damages, shall be the responsibility of the
12 grant recipient and the authorizing agency; and be it

13 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
14 supplant expenditures controlled by this body.






