Resolution authorizing the San Francisco Department of Public Health, Community Behavioral Health Services (SFDPH, CBHS), to enter retroactively into the first year of an agreement with the University of California San Francisco (UCSF), the primary contractor, and expend funds in the amount of \$52,190 to provide local and multi-site evaluation of the integration of buprenorphine treatment into the SFGH AIDS Program; for the period of September 1, 2004 to August 31, 2005.

WHEREAS, UCSF is the recipient of a grant award from the Department of Health and Human Services, National Institutes of Health, for a program titled, Integrating Buprenorphine into the SFGH AIDS Programs; and,

WHEREAS, UCSF and SFDPH,CBHS have agreed to enter into a subcontract agreement to participate in this project; and,

WHEREAS, UCSF has agreed to reimburse SFDPH,CBHS in the amount of \$52,190 from this award under the terms for Year 1 of this subcontract agreement; and,

WHEREAS, As a condition of receiving the funds, UCSF requires SFDPH,CBHS to enter into an agreement (The "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>050642</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The subcontract budget includes provision for indirect costs of \$4,190; and,

WHEREAS, This Resolution requires expedited review by the Board of Supervisors because we did not receive the subcontract until March 22, 2005; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on the consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; now, therefore, be it

RESOLVED, That SFDPH,CBHS is hereby authorized to enter retroactively into a Year 1 subcontract agreement in the amount of \$52,190 with UCSF, the primary contractor; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
