Resolution determining and declaring that the public interest and necessity demand the acquisition, construction or completion of street reconstruction, payement renovation, disabled access curb ramp construction, sidewalk and street improvements, street structure rehabilitation and improvements, pedestrian safety street and signal improvements, street improvements for bicycle use and all other structures and improvements necessary or convenient for the foregoing purposes; finding that the estimated cost of \$208,000,000 for such improvements is and will be too great to be paid out of the ordinary annual income and revenue of said City and County and will require the incurring of a bonded indebtedness: finding the proposed project is in conformity with the priority policies of Planning Code Section 101.1(b) and with the General Plan consistency requirement of Administrative Code Section 2A.53.

WHEREAS, Over the last decade the City and County of San Francisco (the "City") has experienced a significant increase in congestion conditions on City streets, accompanied by funding shortfalls for street maintenance and improvements and a projected decline in revenues available for such projects; and,

WHEREAS, Over the same period, the number of accidents and fatalities involving pedestrians and bicyclists has registered an alarming increase; and,

WHEREAS, City staff has identified a backlog totaling over \$208,000,000 in projects relating to street reconstruction, pavement renovation, disabled access curb ramp construction, sidewalk and street improvements, street structure rehabilitation and improvements and pedestrian and bicycle safety street and signal improvements, all within the City: and.

WHEREAS, This Board recognizes the need to identify funding to address the maintenance and rehabilitation needs identified above in order to provide for the safety of the City's residents and avoid a complete reconstruction of deteriorating streets and sidewalks at a significantly larger cost in the future; and,

WHEREAS, Current transportation revenues, including the local half-cent sales tax for transportation, are insufficient to address the backlog described above; and,

WHEREAS, It is clear that the current pace of improvement to City streets has been slowed by the limited availability of funds for such purposes; and,

WHEREAS, Considerable progress could be made in preventing unnecessary pedestrian and bicyclists' deaths and injuries if additional funding was made available in the short and medium term; now therefore, be it

RESOLVED, By the Board of Supervisors of the City and County of San Francisco:

Section 1. It is hereby determined and declared that the public interest and necessity demand the acquisition, construction or completion of street reconstruction, pavement renovation, disabled access curb ramp construction, sidewalk and street improvements, street structure rehabilitation and improvements, pedestrian safety street and signal improvements, street improvements for bicycle use and all other structures and improvements necessary or convenient for the foregoing purposes.

Section 2. The estimated cost of \$208,000,000 for such improvements is and will be too great to be paid out of the ordinary annual income and revenue of said City and County, will require an expenditure greater than the amount allowed therefor by the annual tax levy, and will require the incurrence of bonded indebtedness in an amount not to exceed \$208,000,000.

Section 3. The Board of Supervisors, having reviewed the proposed legislation, finds and declares (i) that the proposed project is in conformity with the priority policies of Section
