13 RESOLVED, that the Director of MOCJ is authorized, on its behalf to submit the
14 attached proposal to BOC and is authorized to sign and approve on behalf of the City and
15 County of San Francisco the attached Grant Award Agreement including any extensions or
16 amendments thereof; and

17 IT IS AGREED that any liability arising out of the performance of this Grant Award
18 Agreement, including civil court actions for damages, shall be the responsibility of the grant
19 recipient and the authorizing agency. The State of California and BOC disclaim responsibility
20 for any such liability.

21 BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to
22 supplant expenditures controlled by this body.

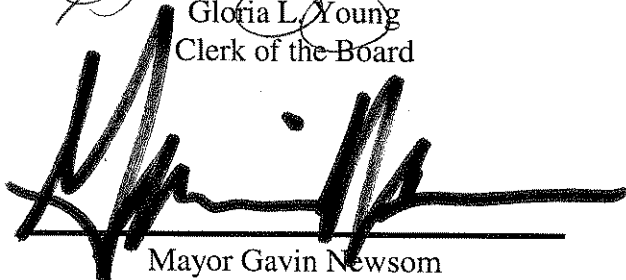
