#### [Public Defender Reguisition Reguest]

### Resolution granting the Office of the Public Defender's Requisition #PE4018/1074384.

WHEREAS, The Office of the Public Defender submitted a requisition that was rejected by the Mayor's Office requesting approval for a new employee (entry level 8174) to replace a vacancy created by the resignation of a misdemeanor attorney; and,

WHEREAS, The department has sufficient monies in its current budget to hire an attorney under 8174; and,

WHEREAS, The unfilled position has created a caseload of 225 unassigned cases, leaving 225 clients without representation; and,

WHEREAS, Leaving the requisition unfilled would require the department to assign private attorneys to the 225 cases, resulting in an approximate cost to the City of \$112,500 in attorney fees; and,

WHEREAS, The department will be forced to reduce 7% of its current misdemeanor caseload, bringing the entire cost to the City to approximately \$419,000 annually; and,

WHEREAS, The annual cost of filling an entry level attorney position is \$69,160; and, WHEREAS, The City would incur \$531,500 in costs if the Public Defender declares

itself unavailable in 1,063 cases (1,063 cases X \$500); and,

WHEREAS, The Board may grant approval of the requisition as per Section 1.1D of the 2003/04 Annual Salary Ordinance; and, now, therefore be it

RESOLVED, The Board of Supervisors approves Requisition #PE4018/1074384 allowing the Office of the Public Defender to fill its empty staff position.
