outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it

FURTHER RESOLVED, that El Reportero, a newspaper which circulates primarily in the Hispanic community of San Francisco and which is printed in San Francisco on one or more days in a calendar week, is hereby designated as the outreach newspaper of the City and County of San Francisco for the Hispanic community, commencing July 1, 2004, for the publication of outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it

FURTHER RESOLVED, that Asian Week, a newspaper which circulates primarily in the Chinese community of San Francisco and which is printed in San Francisco on one or more days in a calendar week, is hereby designated as the outreach newspaper of the City and County of San Francisco for the Chinese community, commencing July 1, 2004, for the publication of outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it

FURTHER RESOLVED, that The Chinese Times, a newspaper which circulates primarily in the Chinese community of San Francisco on one or more days in a calendar week, is hereby designated as the outreach newspaper of the City and County of San Francisco for the Chinese community, commencing July 1, 2004, for the publication of outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it

FURTHER RESOLVED, that The China Press, a newspaper which circulates primarily in the Chinese community of San Francisco and which is printed in San Francisco on one or more days in a calendar week, is hereby designated as the outreach newspaper of the City and County of San Francisco for the Chinese community, commencing July 1, 2004, for the publication of outreach advertising as determined by the Clerk of the Board of Supervisors in accordance with Section 2.80-1(d) of the San Francisco Administrative Code; and, be it
