RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the issuance of a Type 42 on-sale beer and wine pubic premises license, to Bakhshish Kaur for San Francisco Comedy Club, located at 50 Mason Street will serve the public convenience and necessity of the people of the City and County of San Francisco.

Conditions: (1) No noise shall be audible beyond the area under control of the licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over

which they have control; (4) The premises shall operate primarily as a comedy club with incidental sales of beer and wine allowed only on performance nights; (5) Sales and service of alcoholic beverages shall be permitted only between the hours of 5:00 p.m. to 2:00 a.m. Wednesday through Saturday; (6) The sale of alcoholic beverages for consumption off premises is strictly prohibited; (7) Petitioners shall not permit nude or topless entertainment, or lingerie type shows; (8) Petitioners shall not permit pool or billiard tables, or any coin operated games or video machines on the premises; (9) Petitioner shall not maintain or construct private viewing room(s) intended for use by patrons.
