Resolution authorizing the San Francisco Department of Public Health (SFDPH) to accept retroactively and expend a grant in the amount of \$426,085 from the San Francisco Health Plan Access Enhancement Fund (SFHPAEF) to increase patient access to health care services and to enter into an agreement, which includes an indemnification clause, for the use of these funds; for the period of January 1, 2004, to June 30, 2006.

WHEREAS, SFDPH has applied for and been awarded a grant from SFHPAEF in the amount of \$426,085 to increase patient access to health care services; and,

WHEREAS, As a condition of receiving the grant funds, SFHPAEF requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 040635 , which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The grant budget includes provision for indirect costs of \$29,220; and, WHEREAS, This Resolution requires expedited review by the Board of Supervisors because the grant award letter was not received until after the grant start date; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; and,

WHEREAS, The City Attorney has reviewed the agreement and its indemnification clause; now, therefore, be it
