3 **Resolution authorizing the Mayor’s Office of Criminal Justice to retroactively accept**

8 WHEREAS, the Mayor’s Office of Criminal Justice (MOCJ) desires to undertake a  
9 certain project, designated Juvenile Accountability Block Grant (JABG), to be funded in part  
10 from funds made available through the JABG Program administered by the Board of  
11 Corrections (BOC), now, therefore, be it

12 RESOLVED, that the Director of MOCJ is authorized, on its behalf to submit the  
13 attached proposal to BOC and is authorized to sign and approve on behalf of the City and  
14 County of San Francisco the attached Grant Award Agreement including any extensions or  
15 amendments thereof; and

16 BE IT FURTHER RESOLVED that the applicant agrees to provide all matching funds  
17 required for said project (including any amendment thereof) under the Program and the  
18 funding terms and conditions of BOC and that the match will be appropriate as required.

19 IT IS AGREED that any liability arising out of the performance of this Grant Award  
20 Agreement, including civil court actions for damages, shall be the responsibility of the grant  
21 recipient and the authorizing agency. The State of California and BOC disclaim responsibility  
22 for any such liability.




