WHEREAS, The Controller's certification is on file with the Clerk of the Board of Supervisors in File No. 041082, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, On July 20, 2004 the Board of Directors of the Municipal Transportation Agency adopted Resolution 04-107; a copy of which is on file with the Clerk of the Board of Supervisors in File No. <u>041082</u>, which is hereby declared to be a part of this
