Falletti for Falletti & Baldocchi Finer Foods, Inc., dba Falletti Foods, will serve the public convenience and necessity of the people of the City and County of San Francisco.

Conditions: (1) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control; (2) Sales and service of alcoholic beverages shall be permitted only between the hours of 7:00 a.m. to 11:00 p.m. each day of the week; (3) Petitioner shall regularly police the area under their control in an effort to prevent the loitering of persons about the premises; (4) Not more than 2000 square feet of the premises will be used for the display of alcoholic beverages; (5) Display windows shall not be covered and no more than 25 percent of the retail storefront will be covered with advertisements. No refrigeration appliances or other large objects shall block the display windows.
