3 Resolution authorizing the San Francisco Department of Public Health (SFPDH) to  
4 accept and expend retroactively a grant in the amount of \$2,000 from the California  
5 Department of Health Services (CDHS), to purchase car/booster seats; for the period of  
6 January 12, 2004 through June 4, 2004 January 30, 2005.

8 WHEREAS, SFPDH has applied for and been awarded a grant from CDHS in the  
9 amount of \$2,000 to provide car/booster seats to hard to reach and diverse communities in  
10 San Francisco; and,

11 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to  
12 comply with the conditions stated in the Notice of Funding Award for Child Safety Seats, a  
13 copy of which is on file with the Clerk of the Board of Supervisors in File  
14 No. 041431, which is hereby declared to be a part of this resolution as if set forth  
15 fully herein; and,

16 WHEREAS, The SFPDH proposes to maximize use of available grant funds on  
17 program expenditures by not including indirect costs in the grant budget; now, therefore, be it


18 RESOLVED, That SFPDH is hereby authorized to accept and expend retroactively a  
19 grant in the amount of \$2,000 from CDHS; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
21 indirect costs in the budget of the agreement; and, be it

22 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
23 agreement on behalf of the City.




