The San Francisco Traffic Code is hereby amended by adding Section 12 32.6.36. to read as follows: 13 SEC. 36.6.36 PARKING CONTROL. PORTIONS OF TURK STREET AND GOLDEN GATE 14 AVENUE. 15 No person shall stop, park, or leave standing any vehicle, whether attended or (a)16 unattended at the following locations: 17 (1)on the south side of Turk Street, between Larkin and Polk Streets; and 18 on the north side of Golden Gate Avenue, between Larkin and Polk Streets. (2)19 The restrictions in subsection (a) shall not apply to official law enforcement vehicles (b)20 permitted to park in these locations by the Federal Protective Service of the Department of Homeland 21 Security, except when parking prohibition regulations for street-cleaning purposes are in effect. 22 Any vehicle found in violation of this Section shall be subject to removal under Section (c)23 22651(n) of the California Vehicle Code. 24 Section 2. The San Francisco Traffic Code is hereby amended by adding Section 25 B2.6.37, to read as follows:

4	(b) The restrictions in subsection (a) shall not apply to official United States Marshals
5	Service vehicles permitted to park in this location by the Federal Protective Service of the Department
6	of Homeland Security, except when parking prohibition regulations for street-cleaning purposes are in
7	effect.
8	(c) Any vehicle found in violation of this Section shall be subject to removal under Section
9	22651(n) of the California Vehicle Code.
