

[Grant of Federal Homeland Security Funds.]

Ordinance authorizing the Department of Emergency Management to accept and expend a grant of \$22,656,000 in funds from the United States Department of Homeland Security through the California Office of Homeland Security under the Urban Area Security Initiatives Program, and incorporating an amendment to the Annual Salary Ordinance to provide for the extension of certain grant-funded positions.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

(a) For the purpose of distributing of federal Homeland Security Grant Funds ("UASI Program") to the San Francisco Bay Area for fiscal year 2006, the United States Department of Homeland Security combined a number of jurisdictions in the Bay Area into one Urban Area Security Initiative Region ("Super-UASI Region"). The federal funds granted to the Super-UASI Region are administered by the State of California through its UASI Program.

(b) Based on instructions from the Office of Grants and Training for the Department of Homeland Security, each Urban Area was required to establish an Urban Area Working Group ("UAWG") to act as an executive steering committee to provide overall governance of the homeland security program in the Urban Area. State and federal officials have determined that the City and County of San Francisco, the City of Oakland, the City of San Jose, Alameda County, and Santa Clara County shall constitute the UAWG for the Bay Area Super-UASI Region.

1 (c) The UAWG for the Bay Area's Super-UASI Region has determined that
2 San Francisco shall be the primary grantee and fiscal agent for the distribution of UASI
3 program funds for fiscal year 2006. As primary grantee, San Francisco will receive
4 \$22,656,000 million in fiscal year 2006 homeland security funds for distribution throughout the
5 Super-UASI Region.

6 (d) The City and County of San Francisco has participated in the federal homeland
7 security programs since their inception and deems participation in these programs as vital to
8 the continued well being of its citizens, and now, therefore, be it

9 Section 2. Authorization to Accept and Expend Grant Funds.

10 The Department of Emergency Management is hereby authorized to accept and
11 expend on behalf of the City and County of San Francisco \$22,656,000 in funds from the
12 United States Department of Homeland Security through the California Office of Homeland
13 Security under the Urban Area Security Initiatives Program provided that the expenditure of
14 funds allocation to San Francisco under this grant shall be subject to approval of the Board of
15 Supervisors. The Department of Emergency Management is further authorized to furnish
16 whatever additional information or assurances the funding agencies may request in
17 connection with this grant, and to execute any and all agreements necessary to complete
18 transfer of the funds. The grant does not include and provisions for indirect costs, indirect
19 costs are hereby waived.

20 Section 3. Grant-Funded Positions; Amendments to Annual Salary Ordinance.

21 The positions that will be funded from the fiscal year 2006 grant funds received by the
22 City under the Urban Area Security Initiatives Program are set forth in Ordinance No. 061585,
23 which amends Ordinance No. 203-06 (Annual Salary Ordinance 2006/2007), to extend the
24 duration of twenty-nine existing positions at the following departments: Department of
25 Emergency Management, Emergency Services Division (DEM), Police (POL), Fire (FIR),

1 Department of Public Health (DPH), and Sheriff (SHF). The fiscal year 2006 grant funds
2 received by the City under the Urban Area Security Initiatives Program will fund the following
3 job classifications and FTEs as extended under the amendment to the Annual Salary
4 Ordinance from April 1 through June 30: DEM, 0942 Manager VII (0.25 FTE), 8315 Assistant
5 Sheriff (0.25 FTE), 1454 Executive Secretary (0.25 FTE), 5291 Planner III (1.75 FTE), 5277
6 Planner I (0.25 FTE), 0931 Manager III (1.00 FTE), 5293 Planner IV (0.25 FTE), 0933
7 Manager V (0.25 FTE); POL, Q 62 Lieutenant (0.25 FTE), Q 52 Sergeant (0.50 FTE); FIR, H
8 51 Assistant Deputy (0.25 FTE), H 20 Lieutenant (0.50 FTE); DPH, 6138 Industrial Hygienist
9 (0.25 FTE), 2820 Senior Health Program Planner (0.25 FTE), 2230 Physician Specialist (0.15
10 FTE); SHF, 8310 Lieutenant (0.25 FTE), 8308 Sergeant (0.25 FTE), 8306 Senior Deputy
11 (0.25 FTE). Ordinance No. 061585, which amends the Annual Salary Ordinance, specifies
12 the number of positions, classification and compensation of positions to be funded by the
13 fiscal year 2006 Urban Area Security Initiatives Program grant funds and is fully incorporated
14 as set forth herein.
