WHEREAS, Procter & Gamble is the nation's second-largest advertiser; and,
WHEREAS, Procter & Gamble has decided against advertising on Dr. Laura
Schlessinger's upcoming TV show and has pulled support from her radio show; and,

WHEREAS, Procter & Gamble is the fourth advertiser to quit Dr. Laura Schlessinger's radio and TV shows; and,

WHEREAS, United Airlines has announced that it will no longer run advertisements in its in-flight magazine for Dr. Laura Schlessinger; now, therefore, be it
