2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 48 ON-SALE
3 GENERAL PUBLIC PREMISES LIQUOR LICENSE IN EXCHANGE FOR A TYPE 47
4 LICENSE TO STEVE SIRIANNI, FOR THE VELVET LOUNGE LOCATED AT 443
5 BROADWAY STREET, WILL SERVE THE PUBLIC CONVENIENCE AND NECESSITY

11 public premises liquor license in exchange for a Type 47 license for The Velvet Lounge,
12 located at 443 Broadway Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48
20 on-sale general public premises liquor license in exchange for a Type 47 license, to
21 Steve Sirianni for The Velvet Lounge, located at 443 Broadway Street will serve the
22 public convenience and necessity of the people of the City and County of San
23 Francisco.

24 Conditions: 1) Entertainment provided shall not be audible beyond the area
25 under control of the licensee. 2) Petitioner(s) shall provide adequate security guards

1 between the hours of 10:00 p.m. and one half hour after closing. 3) Petitioner(s) shall
2 be responsible for maintaining free of litter the area in front of and adjacent to the
3 premises over which they have control.

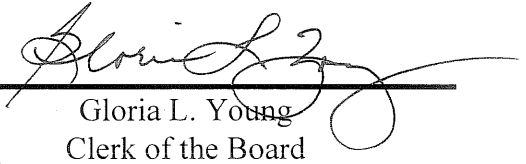

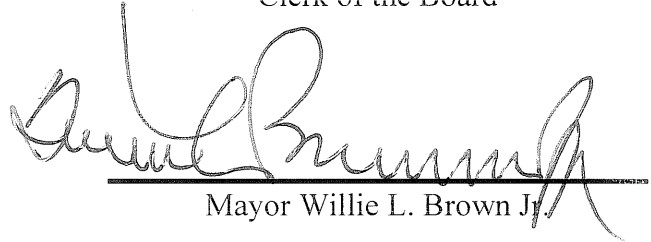
