2 URGING THE SAN FRANCISCO UNIFIED SCHOOL DISTRICT TO DEVELOP A
3 COMMUNITY NOTIFICATION POLICY TO INFORM SURROUNDING RESIDENTS AND
4 PROPERTY OWNERS WHEN THE SCHOOL DISTRICT IS PROPOSING A NEW OR
5 RELOCATED SCHOOL, SCHOOL-RUN PROGRAM, OR OTHER DEVELOPMENT.

7 WHEREAS, the San Francisco Unified School District intends to relocate a number of
8 schools and school-run programs from their current locations to new locations throughout San
9 Francisco; and,

10 WHEREAS, Additionally, the San Francisco Unified School District intends to include a
11 housing component at the new Parkside Elementary School site; and

12 WHEREAS, How school sites are utilized impacts the surrounding neighborhoods;
13 and,

14 WHEREAS, It is important that the residents who live in the neighborhoods affected by
15 proposed changes be informed by the school district and involved in the decision-making
16 process; and,

17 WHEREAS, Currently the school district does not have a process in place for informing
18 affected residents and property owners; and

19 WHEREAS, The method by which the school district communicates its plans to
20 impacted communities should be consistent and uniform; now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
22 urges the San Francisco Unified School District to develop a Community Notification Policy to
23 inform surrounding residents and property owners when the school district is proposing a new
24 or relocated school, school-run program, or other development.




