RESOLUTION NO. 306-13

1 [Liquor License Transfer - 2675 Geary Boulevard]  
2

3 **Resolution determining that the transfer of a Type 21 off-sale general license from**  
4 **500-2<sup>nd</sup> Avenue to 2675 Geary Boulevard (District 2), to Beth Aboulafia for Target**  
5 **Corporation, dba City Target, will serve the public convenience or necessity of**  
6 **the City and County of San Francisco, in accordance with California Business**  
7 **and Professions Code, Section 23958.4, and recommending that the California**  
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**  
9 **the license.**

11 WHEREAS, Beth Aboulafia is seeking the transfer of a Type 21 off-sale general  
12 license from 500-2<sup>nd</sup> Avenue to 2675 Geary Boulevard (District 2) for Target  
13 Corporation, dba City Target; and,

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and,

16 WHEREAS, The Police Department has filed one (1) protest with the Department  
17 of Alcoholic Beverage Control under the California Business and Professions Code,  
18 Section 24013, and recommends that the Department of Alcoholic Beverage Control  
19 issue the liquor license without conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Sales of alcoholic beverages shall be permitted between the hours of 7:00  
22 a.m. and 11:00 p.m. daily, except from Thanksgiving Day to New Year's Day, sales of  
23 alcoholic beverages shall be permitted from 6 a.m. to 12 midnight; 2) No more than 5%  
24 of the square footage of the premises will be used for the display of alcoholic

1 beverages; 3) The sale of distilled spirits in sizes smaller than 200 ml is strictly  
2 prohibited; 4) No malt beverage shall be sold with an alcoholic content greater than  
3 5.7% by volume except for microbrews, craft brews, organic and specialty malt products  
4 sold under such designations as stout, porter, IPA and ESB. This condition is intended  
5 to eliminate high alcohol, low-cost products that are frequently abused, but not prevent  
6 the sale of specialty and craft beer products; 5) The sale of beer or malt beverages in  
7 quantities of 16 oz., 20 oz., 22 oz., 32 oz., 40 oz., or similar size containers is  
8 prohibited, except for microbrews, craft brews, organic and specialty malt products sold  
9 under such designations as stout, porter, IPA and ESB. This condition is intended to  
10 eliminate high alcohol, low-cost products that are frequently abused, but not prevent the  
11 sale of specialty and craft beer products; 6) No beer or malt beverages or wine coolers  
12 shall be sold in quantities of less than the manufacturer pre-packaged multi-unit  
13 quantities of four (4) or more; 7) No wine shall be sold with an alcoholic content of great  
14 than 15% by volume except for "Dinner Wines" which have been aged two years or  
15 more and maintained in corded bottles; and 8) Wine shall not be sold in bottles or  
16 containers smaller than 750 ml unless sold in the manufacturer pre-packaged multi-unit  
17 quantities; now, therefore, be it

18       RESOLVED, That in accordance with the California Business and Professions  
19 Code, Section 23958.4, the Board of Supervisors of the City and County of  
20 San Francisco hereby determines for the foregoing reasons that the transfer of a Type  
21 21 off-sale general license from 500-2nd Avenue to 2675 Geary Boulevard (District 2)  
22 for Target Corporation, dba City Target, will serve the public convenience or necessity  
23 of the City and County of San Francisco.

1           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
2 San Francisco hereby endorses and adopts the recommendations of the Police  
3 Department listed above, and recommends that the Department of Alcoholic Beverage  
4 Control issue the license with those conditions.
