URGING GOVERNOR GRAY DAVIS AND THE STATE LEGISLATURE TO FUND A STUDY EXAMINING THE FEASIBILITY OF A NEW BART STATION AT 30^{TH} & MISSION STREETS IN SAN FRANCISCO.

WHEREAS, A new 30th and Mission BART station would be the first new BART station in San Francisco since the completion of the Embarcadero station in the mid-1970's and would close the largest gap in the single San Francisco BART line; and,

WHEREAS, The new station would serve San Francisco's Mission, Bernal Heights, Upper Noe Valley, Fairmont Heights and Glen Park neighborhoods and provide excellent connections between the BART and several important MUNI routes, including the J Church, 14 Mission, 24 Divisadero, 26 Valencia and 67 Bernal Heights, generating nearly 5,000 new transit trips daily by 2010; and,

WHEREAS, The new station would also support economic development of the Bayview-Hunters Point commercial district and the redevelopment of the Hunters Point Shipyard by providing the regional transit connection for these areas via the 24 Divisadero Muni line; and,

WHEREAS, A \$2,000,000 technical feasibility study is needed for the proposed station-pocket track, including analyses of the site, transit connections, construction impacts, and ridership; and,

WHEREAS, The feasibility study would also include a Transit-Oriented Community Plan process conducted by the San Francisco Planning Department, including a community planning process to develop a land use plan and a neighborhood specific plan, with full environmental review; and,

WHEREAS, Governor Gray Davis and the state legislature are currently assessing statewide transportation priorites for the upcoming fiscal year's budget; and,

WHEREAS, The state has already committed resources to corridor studies of BART stations in Antioch and Richmond as well as capital funds for a BART extension to San Jose; and,

WHEREAS, The 30th & Mission BART station is an important proposal for the City of San Francisco and merits strong consideration as a regional transportation priority; now, therefore be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco urges Governor Gray Davis and the state legislature to fund a study examining the feasibility of a new BART station at 30th & Mission Streets in San Francisco; and, be it

FURTHER RESOLVED, That a copy of this resolution be forwarded to his Honor, the Mayor, with a request that he transmit copies to the California Department of Transportation, the Honorable Governor Gray Davis, and the members of San Francisco's Assembly and Senate delegation.
