[SUPPORTING HOUSE CONCURRENT RESOLUTION 356]

URGING THE U.S. HOUSE OF REPRESENTATIVES TO PASS "THE APOLOGY FOR SLAVERY RESOLUTION OF 2000," HOUSE CONCURRENT RESOLUTION 356.

WHEREAS, On June 19, 2000, Rep. Tony Hall, D-Ohio, called for Congress to formally apologize for promoting and sustaining slavery and its legacy through "The Apology for Slavery Resolution of 2000," House Concurrent Resolution 356; and,

WHEREAS, Approximately 4,000,000 Africans and their descendants were enslaved in

the U.S. and the 13 American colonies between 1619 and 1865; and,

WHEREAS, Slavery has denied African Americans the fruits of their own labor and was an immoral and inhumane deprivation of life, liberty, the pursuit of happiness, citizenship rights, and cultural heritage; and,

WHEREAS, Rep. Tony Hall put this resolution forward because it is the right thing to do and it would set a historical precedent; and,

WHEREAS, Congress has offered apologies before—for instance, in 1988, Congress apologized to Japanese-Americans for imprisoning them during World War II; and,

WHEREAS, Rep. Tony Hall's resolution states that Congress should establish a commission to study the legacy of slavery; and

WHEREAS, The resolution further states that Congress should establish a National museum and memorial regarding slavery as it relates to U.S. and African American history; now, therefore be it
