APPROVING A PURCHASE OF LAND FROM ADAPTEC CORPORATION IN MILPITAS, \$\frac{\frac{5494,519}{494,519}}{494,519}\$-AND AUTHORIZING ACCEPTANCE OF A GRANT DEED AND AN EASEMENT DEED AND EXECUTION OF A GROUND LEASE TO ADAPTEC CORPORATION FOR A TERM OF TWENTY-FIVE YEARS AT AN INITIAL RENT OF \$26,557.00 PER YEAR.

WHEREAS, The City and County of San Francisco owns certain real property under the jurisdiction of the San Francisco Public Utilities Commission (SFPUC) in the City of Milpitas, County of Santa Clara, being a portion of its Bay Division Pipelines No. 3 and No. 4 right of way; and,

WHEREAS, The SFPUC has agreed with Santa Clara Valley Water District (SCVWD) to cooperate in design, construction and operation of an Intertie Pipeline and Pump Station and to share equally in the costs of land acquisition (Parcels A and B as shown on maps of SFPUC on file in the office of the Clerk of the Board of Supervisors in File No. <u>001049</u>), with the Pump Station Parcel A to be held by the City and County of San Francisco and the Pipeline Parcel B to be jointly held with SCVWD; and,

WHEREAS, The SFPUC has determined that the most practical location for the proposed Intertie Pump Station is within land of Adaptec Corporation adjacent to the SFPUC right of way, which is leased to Adaptec Corporation for employee parking, and the Intertie Pipeline must traverse other land of Adaptec Corporation to connect with SCVWD facilities; and,

WHEREAS, The Director of Property has determined the fair market value of the Adaptec Corporation Property and Adaptec Corporation has agreed to sell for fair market value plus a new ground lease with a longer term for the land that it presently leases from the City and County of San Francisco; now therefore, be it

RESOLVED. That this Board of Supervisors in accordance with the recommendations of the

San Francisco Public Utilities Commission and the Director of Property hereby authorizes and approves the purchase of Adaptec Property Parcel A and Parcel B for Four Hundred Ninety—One Thousand—Three Hundred Nineteen Dollars (\$494,519)

Thousand—Three Hundred Nineteen Dollars (\$491,319.00)—and approves the execution of a new ground lease to Adaptec Corporation for a term of twenty-five years and at an initial annual rent of \$26,557.56, with annual (CPI) adjustments and reappraisal of fair market value at five year intervals to establish new annual rent, all on the terms and conditions as set forth in that certain Agreement of Purchase and Sale for Real Estate with a Grant Deed, an Easement Deed and a Ground Lease as attachments (the "Agreement"), copies of which are on file in the offices of the Clerk of the Board of Supervisors in File No. \_\_001049\_; and, be it

FURTHER RESOLVED, That this Board of Supervisors authorizes the Director of Property, on behalf of the City and County of San Francisco, to accept the Grant Deed and Easement Deed from Adaptec Corporation and for City to execute the Ground Lease to Adaptec Corporation, all as recommended by the San Francisco Public Utilities Commission in its Resolution No. 00-0136, a copy of which is on file with the Clerk of the Board of Supervisors in file No. 001049, and as approved by the City Attorney; and, be it

FURTHER RESOLVED, That all actions authorized by this resolution and heretofore taken by any City official in connection with the subject matter hereof are hereby ratified, confirmed and approved by this Board of Supervisors.
