APPROVING AN AGREEMENT BETWEEN THE CITY AND COUNTY OF SAN FRANCISCO AND THE BAY AREA RAPID TRANSIT DISTRICT AUTHORIZING PAYMENT TO SAN FRANCISCO MUNICIPAL RAILWAY FOR TRANSFER TRIPS PROVIDED IN FY2000.

WHEREAS, The Municipal Railway's FY2000 budget included a payment from BART estimated at \$2,145,054; and

WHEREAS, That payment is based on a historical agreement whereby BART agrees to annually reimburse MUNI to recognize that many BART patrons use MUNI to link up with their BART trips, and that these patrons would not take BART at all were it not for the MUNI link; and

WHEREAS, Historically BART has based its payment to MUNI on the prior year's payment with adjustments for changes in BART sales tax revenues; and

WHEREAS, Approval of the annual payment has been done on an annual basis; and WHEREAS, MUNI and BART staff have agreed that the amount due to MUNI for FY2000 is \$2,175,648; and

WHEREAS, On April 25, 2000 the Municipal Transportation Agency Board adopted

Resolution No. 00-041 , authorizing the Director of Municipal Transportation Agency to execute an agreement with BART concerning the FY2000 transfer payment from BART to MUNI; and

WHEREAS, The Board of Supervisors has reviewed the proposed agreement, and determined that BART's annual payment to MUNI increases MUNI's ability to provide feeder bus transit service to BART stations, thus encouraging transit use and benefiting patrons of both BART and MUNI; now, therefore be it

RESOLVED, That the Board of Supervisors hereby authorizes the Director of Municipal Transportation Agency to execute the attached Agreement with BART to effect the FY2000 payment from BART to MUNI.
