17 WHEREAS, The Bart Area Rapid Transit Agency board of directors has recognized the  
18 need to extend gender identity employment protection to its employees and contractors; and,

19 WHEREAS, the Bart Area Rapid Transit Agency board of directors has demonstrated  
20 a commitment to equal civil rights for all citizens by their actions and deeds, therefore, be it,

21 RESOLVED, that the City and County of San Francisco Board of Supervisors hereby  
22 commends the; Bart Area Rapid Transit Agency and, be it

23 FURTHER RESOLVED, that the City and County of San Francisco Board of  
24 Supervisors hereby urges all other public and private employers to add gender identity  
25 employment discrimination protection to their personnel policy and procedures.




