Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only between the hours of 9:00 a.m. to 9:00 p.m. each day of the week. 2) The petitioner(s) shall be responsible for maintaining free of litter the area in front of and adjacent to the

premises over which they have control. 3) There shall be no video/mechanical amusement devices upon the premises at any time. 4) No pay phone will be maintained on the interior or exterior of the premises. 5) No beer products shall be sold in less than six pack quantities per sale unless accompanied by a food purchase. 6) Wine shall not be sold in bottles or containers smaller than 750 ml, and wine-coolers shall not be sold in units of less than a four pack unless accompanied by a food purchase. 7) No person under the age of 21 shall sell or package alcoholic beverages. 8) No more than 20 % of the square footage of the premises will be used for the sale of alcoholic beverages.
