2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF- SALE  
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 3149 MISSION  
4 STREET TO 1342 IRVING STREET TO ARA KIRAKOS-SHIRVANYAN FOR ARMINIA  
5 MARKET WILL SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE  
6 PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE  
7 WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS  
8 CODE. WITH CONDITONS.

10 WHEREAS, Ara Kirakos-Shirvanyan is seeking transfer of a Type 21 off-sale  
11 general alcoholic beverage control license for Arminia Market located at 1342 Irving  
12 Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 3149 Mission Street to 1342  
21 Irving Street for Ara Kirakos-Shirvanyan for Arminia Market, will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only  
24 between the hours of 9:00 a.m. to 9:00 p.m. each day of the week. 2) The petitioner(s)  
25 shall be responsible for maintaining free of litter the area in front of and adjacent to the

1 premises over which they have control. 3) There shall be no video/mechanical  
2 amusement devices upon the premises at any time. 4) No pay phone will be  
3 maintained on the interior or exterior of the premises. 5) No beer products shall be sold  
4 in less than six pack quantities per sale unless accompanied by a food purchase. 6)  
5 Wine shall not be sold in bottles or containers smaller than 750 ml, and wine-coolers  
6 shall not be sold in units of less than a four pack unless accompanied by a food  
7 purchase. 7) No person under the age of 21 shall sell or package alcoholic beverages.  
8 8) No more than 20 % of the square footage of the premises will be used for the sale of  
9 alcoholic beverages.


