DEPARTMENT OF PUBLIC HEALTH, DEPARTMENT OF HUMAN RESOURCES,
COMMISSION ON THE AGING, AND MAYOR'S OFFICE OF DISABILITY TO PROMOTE
THE INITIATIVE AMONG LOW-INCOME SENIOR AND DISABLED SAN FRANCISCANS.

WHEREAS, The United States Social Security Administration, in cooperation with the State of California, has selected San Francisco to be the national demonstration city for the Medicare Enrollment Initiative; and,

WHEREAS, The Medicare Enrollment Initiative pays the Part B \$45.50 monthly premiums for qualified low-income seniors and disabled persons; and,

WHEREAS, Medicare Part B pays for physician services, durable medical equipment, home health care, kidney dialysis, ambulance service, and other medical care and certain practitioners; and,

WHEREAS, With Part B coverage, tens of thousands of San Franciscans can have comprehensive health insurance; and,

WHEREAS, The Social Security Administration estimates that there are 40,000 qualified San Franciscans, however, only 118 San Franciscans are enrolled in the program; and,

WHEREAS, The four-month pilot marketing campaign will focus on community outreach as the primary method of information dissemination to encourage the indigent elderly and disabled to enroll in a program that can improve their access to health care; and,

SUPERVISOR LENO, NEWSOM, BROWN BOARD OF SUPERVISORS WHEREAS, The pilot marketing campaign will consist of print, television, radio, and video materials in English, Cantonese, Tagalog, Spanish, and Vietnamese; and,

WHEREAS, Campaign materials will be distributed through senior centers, religious institutions, health care clinics, food banks, shelters, senior residences, festivals, fairs, and businesses that serve the elderly or employ people whose parents or grandparents may be eligible for the program; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco commends the United States Social Security Administration for selecting San Francisco as the national demonstration city for the Medicare Enrollment Initiative; and, be it

FURTHER RESOLVED, That the Board urges the San Francisco Department of Public Health, Department of Human Resources, Commission on the Aging, and Mayor's Office of Disability to promote the initiative among low-income senior and disabled San Franciscans.
