[Accept and Expend - State Restitution Funds]

AUTHORIZING THE DISTRICT ATTORNEY OF THE CITY AND COUNTY OF SAN FRANCISCO TO RETROACTIVELY CONTRACT FOR, ACCEPT, AND EXPEND FUNDS IN THE AMOUNT OF \$63,952, AND WAIVING INDIRECT COSTS DUE TO FUNDING CONSTRAINTS, WHICH HAVE BEEN ALLOCATED FROM THE STATE BOARD OF CONTROL, VICTIMS OF CRIME AND RESTITUTION PROGRAM, AN AGENT OF THE STATE OF CALIFORNIA, FOR A PROJECT ENTITLED "DISTRICT ATTORNEY'S CONTRACT - CRIMINAL RESTITUTION COMPACT", FOR THE TWELVE MONTH PERIOD July 1, 2000 THROUGH June 30, 2001.

WHEREAS, The District Attorney and the City and County of San Francisco desire to enter into an agreement between the District Attorney's Office and the State Board of Control Victims of Crime and Restitution Program in accordance with Government Code Section 13835, for the purpose of working with the county criminal justice system to ensure restitution fines and orders are properly administered; and

WHEREAS, the funds received hereunder shall not be used to supplant local funds that would, in the absence of the California Victims of Crime and Restitution Programs, be made available to support the assistance of victims and witnesses of crime, now, therefore, be it,

RESOLVED, That the District Attorney of the City and County of San Francisco is hereby authorized to retroactively contract for, accept and expend funds in the amount of \$63,952, waiving indirect costs, for a project entitled "District Attorney Contract - Criminal Restitution Compact" for the twelve-month period July 1, 2000 through June 30, 2001, and,
