FURTHER RESOLVED, That the applicant agrees to provide all inkind or cash match contributions required for said project (including any amendments thereof) under the program and funding terms and conditions of OCJP; and be it

FURTHER RESOLVED, That any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability; and be it

FURTHER RESOLVED, That grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
