2 AUTHORIZING THE OFFICE OF THE DISTRICT ATTORNEY TO RETROACTIVELY
3 CONTRACT FOR, ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF \$565,359, AND
4 WAIVE INDIRECT COSTS DUE TO FUNDING CONSTRAINTS, WHICH HAVE BEEN
5 ALLOCATED FROM THE STATE BOARD OF CONTROL VICTIMS OF CRIME PROGRAM,
6 AN AGENT OF THE STATE OF CALIFONRIA, FOR A PROJECT ENTITLED "JOINT
7 POWERS AGREEMENT WITH VICTIM AND WITNESS ASSISTANCE PROGRAM" FOR THE
8 TWELVE MONTH PERIOD OF July 1, 2000 THROUGH June 30, 2001.

9 WHEREAS, The District Attorney's Office and the City and County
10 of San Francisco desire to continue a certain project designated the
11 Joint Powers Agreement between the Victim and Witness Assistance
12 Program and the State Board of Control Victims of Crime Program in
13 accordance with Government Section 13835, for the purpose of
14 verification of victim compensation claims; and,

15 WHEREAS, the funds received hereunder shall not be used to
16 supplant local funds that would, in the absence of the California
17 Victim Witness Assistance Program, be made available to support the
18 assistance of victims and witnesses of crime, now therefore, be it

19 RESOLVED, that the District Attorney of the City and County of
20 San Francisco, is authorized to retroactively contract for, accept
21 and expend funds of \$565,359, waiving indirect costs, for a project
22 entitled "Joint Powers Agreement with Victim and Witness Assistance
23 Program" for the twelve-month period of July 1, 2000 through June 30,
24 2001 and to execute and amend said project except as any amendment




